

## DISTRIBUTION DATE INFORMATION FORM

This Distribution Date Information Form (the "Information Form") is being provided by Wells Fargo Bank, National Association, as trustee (the "Indenture Trustee") pursuant to Section 4.22 of the Indenture of Trust, dated as of March 1, 2011 (the "Indenture"), between Educational Funding of the South, Inc.
